Section 3. Hazardous Identification

Potential Health Effects, Signs and Symptoms of Exposure:

Primary Route of Entry	r: Eyes, skin or inhalation
Eye:	Vapors cause eye irritation. Splashes cause severe irritation, possible corneal burns and eye damage.
Skin:	May cause irritation with redness and pain. May be absorbed through the skin with possible systemic effects.
Ingestion:	Can cause drowsiness, unconsciousness, and death. Gastrointestinal pain, cramps, nausea, vomiting and diarrhea may also result. The single lethal dose for a human adult = about 250 mls (8 ounces).
Inhalation:	Inhalation of vapors irritates the respiratory tract. Exposure to high concentrations has a narcotic effect, producing symptoms of dizziness, drowsiness, headache, staggering, unconsciousness and possibly death.
Chronic Exposure:	Chronic exposure may cause skin effects.
Aggravation of Pre- existing Conditions:	Persons with pre-existing skin disorders or impaired liver, kidney, or pulmonary function may be more susceptible to the effects of this agent.

Section 4. First Aid Measures

Extinguisher Media:	Water spray, dry chemical, alcohol foam, or carbon dioxide. Water spray may be used to keep fire exposed containers cool, dilute spills to nonflammable mixtures, protect personnel attempting to stop leak and disperse vapors.
Explosion:	Above flash point, vapor-air mixtures are explosive within flammable limits noted above. Contact with strong oxidizers may cause fire or explosion. Vapors can flow along surfaces to distant ignition source and flash back. Sensitive to static discharge.
Special Information:	In the event of a fire, wear full protective clothing and NIOSH-approved self-contained breathing apparatus with full face piece operating in the pressure demand or other positive pressure mode.

Section 6. Accidental Release Measures

Spill or Release Procedures: Ventilate area of leak or spill. Remove all sources of ignition. Wear appropriate personal protective equipment as specified in section 8. Isolate hazard area. Keep unnecessary and unprotected personnel from entering. Contain and recover liquid when possible. Use non sparking tools and equipment. Collect liquid in an appropriate container or absorb with an inert material (e.g., vermiculite, dry sand, earth), and place in a chemical waste container. Do not use combustible materials, such as saw dust. Do not flush to sewer. If a leak of spill has not ignited, use water spray to disperse the vapors, to protect personnel attempting to stop leak, and to flush spills away from exposures.

Section 7. Handling and Storage

Handling & Storing: Protect against physical damage. Store in a cool, dry well ventilated location away from any area where the fire hazard may be acute. Outside or detached storage is preferred. Separate from incompatibles. Containers should be bonded and grounded for transfers to avoid Static sparks. Storage and use areas should be No Smoking areas. Use non sparking type tools and equipment, including explosion proof ventilation. Containers of this material may be hazardous when empty since they retain product residues (vapors, liquid); observe all warnings and precautions listed for the product. Small quantities of peroxides can form on prolonged storage. Exposure to light and/or air significantly increases the rate of peroxide formation. If evaporated to a residue, the mixture of peroxides and isopropanol may explode when exposed to heat or shock.
